

Senate 2188: Relating to Land Development (Legislative History)

S2188 GENERAL BILL/CS/CS/1ST ENG by Finance and Taxation; Comprehensive Planning; Comprehensive Planning (Similar [H 1593](#), Compare 2ND ENG/[H 0293](#), CS/CS/CS/[S 1104](#), CS/2ND ENG/[S 2548](#))

Land Development; provides for issuance of escheatment tax deed that is free & clear of any tax certificates, accrued taxes, & liens of any nature for certain properties; provides immunity for county from environmental liability for certain properties that escheat to county; **requires DCA, in cooperation with other specified state agencies, to provide assistance to local govts. in implementing provisions re rural land stewardship areas**, etc. Amends FS. EFFECTIVE DATE: 07/01/2004.
